Design and Development Centre for Defence Technologies in India in 2020

Editor's Synopsis

- Adani and Elbit have agreed to setup a "Design and Development centre for Defence Technologies"
- Adani Elbit Advanced Systems India Limited, is a joint venture between Adani Enterprises, India and Elbit Systems, Israel
- The JV's facility in Hyderabad is the nation's first private UAV manufacturing complex and the only Hermes900 production facility outside Israel

Lucknow, 06 February 2020: Adani Elbit Advanced Systems India Limited, a joint venture between Adani Defence & Aerospace and Elbit Systems, Israel had set up the first private UAV manufacturing complex at Adani Aerospace Park in Hyderabad to indigenize unmanned aerial platforms. The only Hermes 900 production facility outside Israel which inaugurated in December 2018, has started exporting Hermes900 Unmanned Aerial Platform to international customers. Hermes 900 is a state of the art, combat proven multi-role unmanned platform with an endurance of 36 hours, payload capacity of 420 kg, altitude of over 32,000 feet (10km+) with applications across civil, defence and homeland security.

Adani Defence & Aerospace and Elbit have agreed to setup a "Design and Development center" focusing on co-developing defence technologies aligned to the global requirements. The design center will facilitate job creation for highly qualified R&D engineers to build products of tomorrow aligned to the needs of the armed forces.

On the sidelines of DefExpo 2020, Adani-Elbit JV launched one of the largest export programs for the production of hundreds of Mini UAV systems for a global customer, with complete platform production and integration from Hyderabad, India.

Adani-Elbit JV is well positioned to deliver the full spectrum of unmanned platforms to Indian Tri Services & allied forces, aligned to "Make in India" requirements and international standards.

Elad Aharonson, Executive Vice President and General Manager - ISTAR Division of Elbit Systems commented, "India is a strategic market for Elbit Systems and we are proud to have been providing our portfolio of technologies and platforms to the Indian Tri Services for decades. Our enduring relationship with Adani Defence & Aerospace has shaped our joint vision to make India a global hub for manufacturing and exports of the

unmanned platforms. It is a testimony of our true partnership, quality of manpower and production processes, speed of execution and ability to scale-up that the JV has showcased in the last few years."

"It is another prestigious program for the JV and a key milestone in our journey to establish leadership position in unmanned segment in India.
